Visa and residence permit

- 1. Procedural fee for issuing a visa for the purpose of obtaining a residence permit EUR 110
- 2. Procedural fee for appealing against a decision related to issuing a visa for the purpose of obtaining a residence permit, if the appeal is lodged at a diplomatic mission or consular post **EUR 160**
- 3. Procedural fee for issuing a residence permit in case of application submitted at the National-Directorate in person **HUF 39 000**
- 4. Procedural fee for issuing a residence permit in case of application submitted via the electronic information system of the National-Directorate **HUF 24 000**
- 5. Procedural fee for the extension of a residence permit in case of application submitted at the National-Directorate in person **HUF 35 000**
