As you may know in 2008 the Programme in Comparative Media Law & Policy of the University of Oxford established the **Monroe E. Price Media Law Moot Court Competition** which aims to foster and cultivate interest in freedom of expression issues and the role of the media and information technologies in societies around the world.

The annual Price Moot Court Competition challenges students to engage in comparative research of legal standards at the national, regional and international levels and to develop their arguments (in written and oral forms) on cutting-edge questions in media and ICT law. The Competition is currently comprised of seven Regional Rounds.

This year the 8th South-East-European Regional Round will be organised by our University, between 4-6th December 2019. The countries eligible for taking part in the competition are the followings: Albania, Austria, Bosnia and Herzegovina, Bulgaria, Czech Republic, Croatia, Greece, Hungary, Italy, Montenegro, North Macedonia, Romania, Russia, Serbia, Slovakia and Slovenia.



As the freedom of expression is a fundamental right which is a cornerstone of a democratic society, it is important for our universities and faculties of law to train our law students in the best way to be able to tackle the difficult questions it raises. That's one of the reasons why **we would like to invite your University and Faculty to take part in this year's competition. There is no registration fee for the South-East-European Regional Round.**
